Illegal Dumping is a Crime

Morris County has taken a stance against illegal dumping. The Office of Health Management has designated a Solid Waste Enforcement Investigator who conducts random, trail camera surveillance and patrols on major illegal dumpsites county-wide. If convicted, you can be fined up to \$5,000.00, be subject to loss of driver's license for a period of six months to a year, forfeiture of vehicles used or intended for use in lawful transportation or disposal of solid waste, and/or community service for up to 90 days.

You can dispose of your waste properly at the following sites:
